Grand Rapids Police have an adult male in custody after he reportedly gained access to a secure area of Spectrum Health Butterworth Hospital and set a small fire. At about 8:20 AM the Grand Rapids Police Department was notified by Spectrum Security that a subject was able to gain access to a secure area of the hospital and set a small fire. Spectrum Security was able to take the suspect into custody with no injuries reported and only minimal damage.

Once officers were on-scene, they learned that the fire was set inside the hospital on an upper level used for mechanical purposes. The fire alarm was pulled and the suspect was able to gain access to the roof and helipad, but no fire was set on the helipad. The Grand Rapids Police Department's Detective Unit has taken custody of the suspect and is currently investigating the incident.

I was dispatched to a rollover accident that occurred at Fulton and Division. When I arrived I observed [REDACTED] Silver Cherokee on its roof in the middle of the intersection. [REDACTED] had crawled out of the accident and sitting on the guardrail on the sidewalk.

[REDACTED] stated that he was SB on Monroe with a green light and [REDACTED] ran the red light and struck his car. The impact caused his car to slide and then flip onto its roof and slid around some more. [REDACTED] in her car immediately fled the scene and didn't stop for a moment.

Witnesses observed the same as [REDACTED] stated and got [REDACTED] plate. See UD-10 for details. From the accident [REDACTED] suffered minor cuts and scraps to his hands but was released at the scene by AMR. Dispatch radioed to area units [REDACTED] car description.

[REDACTED] then apparently went around the block and got into another accident at Fulton/Jefferson. See 28058 for that report.

[REDACTED] then immediately went to [REDACTED] where her mother lives and hid the car behind the house in the driveway so it wasn't visible from the street. [REDACTED] then went inside. An unk witness had followed [REDACTED] to the house and flagged down Ofc Gootjes and Ofc Baylis who were in the area. The unk witness refused to give his name but pointed out the house where [REDACTED] went inside.

Ofc Gootjes and Baylis made contact with [REDACTED] at the door. [REDACTED] didn't speak English and State Trooper Ayala came by to assist with translation. [REDACTED] told Ayala that she was WB on Fulton and had a green light. When she went through the intersection an unk driver going south ran the red light and she hit him. She stated that she got scared and fled the scene. She then went to her mothers house where she stated that she was waiting for us and figured we would come and talk to her.

[REDACTED] doesn't remember getting into a second accident. SOS showed her valid. Due to her seeing the rollover of the car she hit, the driver of that car sustaining minor injuries, [REDACTED] getting into another accident and then hiding the car at her mothers and not notifying or calling the police she was arrested for fleeing the scene of a PI accident.

She was given tickets from the second accident (flee scene of PDX and ran red light) and red light ticket for the first accident. I transported her to KCCF where she was lodged.
