ORDER OF DISMISSAL

At a session of said Court, held in the Ann Arbor Justice Center, Ann Arbor, Michigan, on:

PRESENT: HON. Elizabeth Rillard Hines

Defendant having been charged with two counts of violating MCL 168.944, and having filed a Motion to Dismiss those charges on the ground that the referenced statute is unconstitutional under the First and Fourteenth Amendments of the United States Constitution, and the People having responded to said Motion, and the Court having heard argument on same and having rendered an oral opinion on January 10, 2019 following which she granted Defendant's Motion;

NOW THEREFORE IT IS ORDERED that Defendant's Motion to Dismiss is GRANTED for the reasons stated on the record on January 10, 2019, including that MCL 168.944 violates the First Amendment both on its face and as applied to Defendant, and that it also is void for vagueness under the First and Fourteenth Amendments.

IT FURTHER IS ORDERED that the charges against Defendant are dismissed with prejudice, and Defendant's bond is canceled.
