After crossing illegally into Laredo, Texas he claimed to have traveled with other illegals by walking for two days then was picked up by a van and taken to San Antonio, Texas. (b) (6), (b) (7)(C) stated he did not see any checkpoints. Once in San Antonio he was taken to Palisades Park, New Jersey. (b) (6), (b) (7)(C) stated the \$5000.00 he paid was for all costs from Guatemala to New Jersey.</p> | | |
| <p>INADMISSIBILITY:</p> <p>Subject is a native and citizen of Guatemala as are both of his parents. He has never had any documents that would allow him to be or remain in the United States legally. Subject is inadmissible under Section 212 (a) (6) (A) (i) of the INA, in that he entered the United States at a time or place not designated by the Attorney General and was not then admitted or paroled after inspection by an immigration officer.</p> | | |
| <p>FACTS OF ARREST:</p> <p>On 03/16/2016, Border Patrol Agent (b) (6), (b) (7)(C) received information from Clio Police Officer (b) (6), (b) (7)(C) concerning a traffic stop he was on with 3 Guatemalan nationals. Officer (b) (6), (b) (7)(C) advised Agent (b) (6), (b) (7)(C) that he suspected the subjects were in the United States illegally because they had no United States identification. He advised that one had provided a Guatemalan voter card, a second had provided an International Driver's License and the third had no identification and would not provide more than a first name. Officer (b) (6), (b) (7)(C) said that the driver barely spoke English and the two passengers spoke only Spanish. Officer (b) (6), (b) (7)(C) stopped the subjects for a broken taillight and was not going to ticket the subjects. Officer (b) (6), (b) (7)(C) did offer to hold the subjects until Border Patrol arrived, but Agent (b) (6), (b) (7)(C) explained that there could be liability issues for both agencies if (b) (7)(E)</p> <p>Agent (b) (6), (b) (7)(C) spoke briefly with the driver, and was able to determine that the subjects were stayin the (b) (6), (b) (7)(C) located at (b) (6), (b) (7)(C) in Flint Township, Michigan. Officer (b) (6), (b) (7)(C) advised that the subjects were driving a white Ford panel van bearing New Jersey plate (b) (6), (b) (7)(C). Officer (b) (6), (b) (7)(C) released the subjects at that time. Agent (b) (6), (b) (7)(C) suspected that all three were most likely in the United States illegally.</p> <p>On 03/17/2016, Border Patrol Agents (b) (6), (b) (7)(C), (b) (6), (b) (7)(C), and (b) (6), (b) (7)(C) were assigned to (b) (7)(E) duties. Agent (b) (6), (b) (7)(C) advised the man that he was a Border Patrol Agent, he hung his head low and stared at his hands, mumbling something. Agent (b) (6), (b) (7)(C) questioned the man as to his citizenship. The man identified himself as (b) (6), (b) (7)(C) of Guatemala. The man advised that he had snuck into the United States illegally through Texas in 2010. Agent (b) (6), (b) (7)(C) radioed to Agents (b) (6), (b) (7)(C) and (b) (6), (b) (7)(C), who responded to the location and assisted.</p> <p>Agent (b) (6), (b) (7)(C) asked (b) (6), (b) (7)(C) where his two companions were.
