**DEFENDANTS' RESPONSE TO PLAINTIFFS' MOTION FOR
CLASS CERTIFICATION**

ORAL ARGUMENT REQUESTED

Defendants, through their counsel, request this Court deny Plaintiffs' Motion for Class Certification for the following reasons, as set forth more thoroughly in their brief in support:

1. Plaintiffs seek certification of two injunctive classes consisting of current and former inmates at the Muskegon County Jail (MCJ). None of the named Plaintiffs is currently an inmate in the Muskegon County Jail. Therefore, Plaintiffs lack standing and are not adequately positioned to represent the purported class.

2. Plaintiffs seek certification of two damages classes, one of all female inmates for the past three years, and one of all inmates for the past three years. Plaintiffs cannot establish the necessary criteria under Fed. R. Civ. P. 23(a) or (b)(3), and therefore, class certification is inappropriate.

Defendants deny that Plaintiffs sought concurrence as contemplated by Local Rule 7.1 before filing this motion, as the same is untrue.

I. Introduction

Plaintiffs are former inmates or pretrial detainees of the Muskegon County Jail. Their lawsuit requests class certification, damages, and injunctive relief against Muskegon County, the Sheriff, Jail Administrator and several officers. The Complaint alleges certain conditions of confinement are unconstitutional. Plaintiffs also filed motions for class certification and injunctive relief. For the reasons stated below, Plaintiffs' motion for class certification must be denied.

II. Statement of Facts

A. The Muskegon County Jail

The Muskegon County Jail (MCJ) was constructed in 1958 with a rated design capacity of 154 beds. The 1978 renovation increased the rated design capacity to 244 beds. The 1999 renovation increased the rated design capacity to its current capacity of 370.

In July 2013, the Muskegon County Board of Commissioners voted to approve a bond sale to finance the construction of a new jail.¹ Construction of the new jail began in January 2014. It is expected to be completed by June 2015. (See Kloosterman, "Timeline: See the recent progression in construction of the Muskegon County Jail," available at http://www.mlive.com/news/muskegon/index.ssf/2014/10/timeline_see_the_recent_progress.html; **Dkt. No. 1**, at ¶ 199)

¹Many, including the Muskegon County Sheriff's Department, advocated for a new jail long before this time.

B. Summary of each Plaintiff's Incarceration for the three years preceding the date of the complaint²

Each Plaintiff was incarcerated at different times in the MCJ during the limitations period. The following is a breakdown of each incarceration, with reference to the respective time periods they were placed in a particular cell. THF is the female holding cell. Cells 36, 37, 38, and 39 are 12-person cells along the third-floor catwalk area. Cell 35 is a 6-person cell along the catwalk opposite the 12-person cells. The third-floor dayroom (3e) contains individual and double-bunk cells. Cell 2e is the second-floor dayroom with individual and double-bunk cells. Each arrest and incarceration is separated by citation to the relevant booking and inmate log records.

⁴ Despite her second incarceration lasting only 4½ months, Plaintiff alleges in the complaint she was incarcerated for six months. (See **Dkt. No. 1**, Complaint at ¶ 86) This is consistent with the exaggerated nature of most of the allegations in the complaint, such as the length of time the inmates were kept in the holding tank. (See, i.e., *id.*, at ¶ 125, alleging she spent 7 days in the holding tank, despite the fact she was in the holding cell for less than one day during both incarcerations)

⁵ Again, as is common throughout the complaint, Ms. Brown exaggerates—she asserts she was held in the jail for 89 days, **Dkt. C. Plaintiffs' Complaint and individual allegations

Plaintiffs' complaint contains numerous allegations spread over 5 counts. The following is a summary of the claims which seem to apply to each of Plaintiffs' 4 requested classes:

- Female Injunctive Class seeks relief for the following: (See **Ecf 1**, Complaint at ¶ 219)
 1. Cross-gender viewing. Plaintiffs allege male inmates and corrections staff have unobstructed views of the female toilets in the holding tank and the individual cells. Plaintiffs allege they were forced to wear one-piece jail uniforms which required them to be completely naked to use the toilet. Plaintiffs also allege male inmate trustees and corrections officers have unobstructed views of all female shower areas. (*Id.* at ¶¶ 53-79)¹⁰
 2. Denial of exercise opportunities. Plaintiffs allege female inmates are limited in their out-of-cell activities as compared to male inmates, and rarely are allowed to use the jail recreational/exercise area. (*Id.* at ¶¶ 80-95)
 3. Denial of feminine hygiene products and adequate clothing. Plaintiffs allege that Defendants sometimes remove female bras without replacing them, and do not provide underwear. Further, Defendants do not provide sanitary napkins immediately upon demand, causing them to soil their clothing. They allege at times it could take hours, and in one instance, two days to receive sanitary napkins. (*Id.* at ¶¶ 96-116)¹¹

⁹ Like her co-Plaintiffs, Ms. Collins alleges she was in the holding cell for "four or five days," despite actually spending less than one day there. (**Dkt. No. 1**, at ¶ 129)

¹⁰ All female inmates have been issued two-piece jail uniforms for at least the past year, a fact known by Plaintiffs' counsel since at least March 2014. Further, Plaintiffs were informed that staffing decisions were made to try to provide female corrections officers to oversee the female population. (See **Dkt. No. 4-12**, Exhibit 21 to Plaintiffs' motion for preliminary injunction, letter from Attorney Hughes, at 2) Further, the toilet in the holding cell is blocked from view by a privacy wall.

¹¹ The records establish these allegations are false. For example, in the twelve-month period from December 2013 to December 2014, the MCJ purchased and distributed over 27,600 female sanitary napkins from its regular supplier, an average of 76 per day. (See **Ex 29**,

- Female Damages Class seeks monetary relief for the same claims, apparently based on the injuries suffered by each Plaintiff:
 1. Semelbauer claims she was forced to wear a one-piece jumpsuit while incarcerated in 2012, causing her to expose her entire body when using the toilet. (*Id.* at ¶64) She was not allowed to use the gym during her 28-day incarceration. (*Id.* at ¶88)
 2. Bosch claims she was forced to wear a one-piece jumpsuit. Her bra was confiscated and her family needed to purchase her another. (*Id.* at ¶¶ 64, 110-111) She was only allowed to use the gym twice during her incarceration. (*Id.* at ¶86)
 3. Vos claims she was observed by a male corrections officer while using the toilet naked. The same officer allegedly removed paper and sheets she tried to use as privacy barriers. (*Id.* at ¶¶ 69-70, 75-77) After demanding sanitary napkins, she allegedly waited several hours before they were provided. (*Id.* at ¶100)
 4. Brown claims she was only allowed to use the gym 1 time during her incarceration. (*Id.* at ¶89) She waited 8 hours to receive sanitary napkins and spent 2 days in the holding cell. (*Id.* at ¶¶105, 126) She was also placed in a suicide smock for an undisclosed period of time. (*Id.* at ¶174)
 5. Baker claims she had to wear a one-piece jumpsuit, and was held in the holding cell for 3 days. (*Id.* at ¶¶ 64, 130) It also took “hours” for her to obtain toilet paper on an undisclosed date. (*Id.* at ¶107) She claims she was never allowed to use the gym. (*Id.* at ¶92)
 6. Speers claims she was only allowed to use the gym 3 times. (*Id.* at ¶91) She also allegedly spent 2 days without sanitary pads, and was only allowed 1 free pair of underwear. (*Id.* at ¶¶104, 113-114)
 7. Kitchens claims she did not receive sanitary napkins for “hours.” (*Id.* at ¶ 103) She also claims she did not get out of the dayroom to exercise and had to walk around her cell and the dayroom for exercise. (*Id.* at ¶90)

correspondence from vendor with spreadsheet indicating order status for sanitary napkins) Further, if there was ever an emergency, the evidence will establish that MCJ personnel would purchase additional sanitary napkins from the local pharmacy or grocery store. (See *id.*)

8. Collins claims she tried to hang a sheet to protect her privacy but it was taken down. (*Id.* at ¶ 74) She claims weight gain and lost muscle mass due to lack of exercise. (*Id.* at ¶ 95) She also spent several hours without sanitary napkins. (*Id.* at ¶ 106)
- General Injunctive Class seeks relief for the following: (*Id.* at ¶224)
 1. Extended stays in overcrowded holding tank. Plaintiffs claim that they and other inmates have been held in the general holding tank for up to weeks at a time. They also allege up to 18 other inmates are housed in the holding tank for the same amount of time.¹² (*Id.* ¶¶ at 117-130)
 2. Other abysmal conditions of confinement. Plaintiffs allege that shower curtains and other areas of the jail have mold and are infested with insects and vermin. Plaintiffs allege the ceiling is falling in parts, and the plumbing and showers do not always work properly. (*Id.* at ¶¶ 131-144)
 3. Severe overcrowding. Plaintiffs allege the population in the Muskegon County Jail routinely exceeds its rated design capacity and some inmates are forced to sleep on cots on the floor of cells. (*Id.* at ¶¶ 145-164)
 4. Nonfunctioning complaint system. Plaintiffs allege Defendants do not respond to complaints or kites in a timely fashion or at all. As a result, they are deliberately indifferent to medical and other needs. (*Id.* at 165-182)
 - General Damages Class seeks monetary relief for these same things, apparently based on the individual Plaintiffs' allegations:
 1. Semelbauer claims she was in the holding tank for 3-4 days. (*Id.* at ¶127)
 2. Bosch claims she was in the holding tank for 7 days. (*Id.* at ¶125) She was burned by hot water. (*Id.* at ¶125) She complained about potentially getting MRSA, though she does not allege to have contracted any disease. (*Id.* at ¶170)

¹² As noted above, Plaintiffs' allegations as to the length of their time in the holding tank are false. Further, their allegation as to the number of inmates occupying the holding tank is misleading. The only times the holding cell exceeds its rated capacity are for short periods during the day as it is used as the staging area for inmates getting ready for court appearances or attorney meetings.

3. Vos claims her tooth pain was ignored. (*Id.* at ¶171)
4. Brown was allegedly burned by hot water and her kites were ignored. (*Id.* at ¶173)
5. Baker claims it took “hours” for her to obtain toilet paper on an undisclosed date. (*Id.* at ¶107)
6. Speers claims she was held in the holding cell for seven days while suffering opiate withdrawals and not given a mat or bedding. (*Id.* at ¶¶ 122-123) She also asserts she was burned by hot water. (*Id.* at ¶ 141)
7. Kitchens does not actually make an allegation in the complaint that asserts damages under these allegations.
8. Collins claims she was kept in the holding tank for four to five days. (*Id.* at ¶129)

III. Legal Analysis

Plaintiff requests this Court certify four separate classes, two injunctive classes and two damages classes. Defendants will address these in turn, starting with the general standard for class certification under Fed. R. Civ. P. 23.

A. Class Actions, Generally

Fed. R. Civ. P. 23 provides that “[o]ne or more members of a class may sue or be sued as representative parties on behalf of all members only if:

- (1) the class is so numerous that joinder of all members is impracticable;
- (2) there are questions of law or fact common to the class;
- (3) the claims or defenses of the representative parties are typical of the claims or defenses of the class; and
- (4) the representative parties will fairly and adequately protect the interests of the class.

“Although Rule 23(a)(2) refers to common questions of law or fact, in the plural, there need only be one question common to the class-though that question must be a

‘common issue the resolution of which will advance the litigation.’ Ultimately, the class may only be certified if, “after a rigorous analysis,” the district court is satisfied that these prerequisites have been met. The burden is on the plaintiff “to establish his right” to class certification.” ***Alkire v. Irving***, 330 F.3d 802, 820 (6th Cir. 2003) (internal citations omitted).

Further, “[t]he definition of a class should not be so broad so as to include individuals who are without standing to maintain the action on their own behalf.” ***Clay v. American Tobacco Company***, 188 F.R.D. 483, 490 (S.D. Ill. 1999). This is because the plaintiffs must not only satisfy the Rule 23(a) criteria, but the proposed representative plaintiffs must also meet the criteria listed in Rule 23(b)(2) or (b)(3).

B. Plaintiffs’ Injunctive Classes¹³

None of the named Plaintiffs are currently incarcerated in the Muskegon County Jail. As such, none of the Plaintiffs is in a position to adequately represent a class of which none of them is a member. Further, none of the Plaintiffs have standing to pursue a claim for injunctive relief. Therefore, the Court must deny class certification for Plaintiffs’ proposed injunctive relief classes.

The U.S. Supreme Court has made clear that “[a] litigant must be a member of the class which he or she seeks to represent **at the time the class action is certified by the district court.**” ***Sosna v. Iowa***, 419 U.S. 393, 403 (1975) (emphasis added); see also ***Clay, supra***. Plaintiff Collins is not currently incarcerated. (See **Ex 28**, Release order) The remaining Plaintiffs are not currently incarcerated.

¹³ Pursuant to Fed. R. Civ. P. 10(c), Defendants incorporate by reference their arguments regarding Plaintiffs’ lack of standing set forth in their response to Plaintiffs’ motion for preliminary injunction. (**Dkt. No. 14**)

In **Rouse v. Caruso**, No. 2:06-CV-10961, 2013 WL 588916, at *4-6 (E.D. Mich. Jan. 7, 2013) Report and Recommendation adopted, No. 06-CV-10961, 2013 WL 569638 (E.D. Mich. Feb. 13, 2013), the Eastern District of Michigan dealt with a situation similar to this case. There, several inmates formerly housed in the Mid-Michigan Correctional Facility (STF), a Michigan Department of Corrections prison, sought class certification under Fed. R. Civ. P. 23(b)(2), and requested injunctive relief for medical treatment conditions within the prison. In denying class certification, the Court stated:

plaintiffs' proposed class and subclasses include both current and former inmates at STF, rendering injunctive relief wholly inapplicable to a substantial portion of the class; **indeed, none of the named plaintiffs remaining in the case could benefit from injunctive relief, as they are all no longer incarcerated at STF.** In short, “[t]he majority of Plaintiffs' proposed class members would lack standing to assert claims for injunctive relief. . . . Accordingly, certification of Plaintiffs' monetary and injunctive claims under Rule 23(b)(2) is not appropriate.” **Rouse**, *supra* *6 (quoting **Gonzales v. Comcast Corp.**, No. 10-cv-01010, 2012 WL 10621, at *18 (Jan. 3, 2012), *magistrate judge's report and recommendation adopted*, 2012 WL 217708 (E.D.Cal. Jan. 23, 2012).) (emphasis added)

No Plaintiff has standing to seek injunctive relief and assert the constitutional rights of others. **Newsom v. Norris**, 888 F.2d 371, 381 (6th Cir. 1989); **Raines v. Goedde**, No. 92-3120, 1992 WL 188120, at *2 (6th Cir. 1992). Since Plaintiffs lack standing to represent any class seeking injunctive relief for conditions at the MCJ, this Court should deny their request to certify the two injunctive classes.¹⁴

¹⁴ Plaintiffs may try and assert, given their criminal histories and apparent inability to remain away from incarceration for more than a year at a time, they can still adequately represent the interest of current and future inmates. Courts have consistently rejected such claims. See, e.g., **Frazier v. George**, 2014 WL 4979315 (M.D. Tenn. 2014) (Rejecting plaintiff's contention “that, because of his past criminal history, there is a reasonable expectation that he will be incarcerated in the Maury County Jail again, and thus again subjected to the same action.”).

C. Plaintiffs' damages classes

This Court should also deny class certification for Plaintiff's proposed damage classes. Plaintiffs cannot establish the typicality and adequacy prongs of the class certification test, for either the female damages class or the general damages class. However, if the Court is inclined to grant class certification to these purported classes based solely on Plaintiffs' allegations, Defendants request the opportunity to conduct discovery, for the limited purpose of exploring Plaintiffs' claims and alleged injuries. This will allow a more thorough analysis of whether the typicality, commonality, and adequacy requirements can be met.

1. Female Damages Class

Plaintiffs must establish that they can meet all of the criteria under Rule 23(a), as well as 23(b)(3), to justify certification of a class action for damages. Here, for purposes of this motion, Defendants concede that Plaintiffs can establish the numerosity requirement. See **Roman v. Korson**, 152 F.R.D. 101, 105 (W.D. Mich. 1993) (noting the "modern trend is to require a minimum of between 21 and 40 members" to meet the numerosity requirement). However, Plaintiffs cannot establish the typicality or adequacy of representation requirements, and as such, their motion for certification with regard to the female damages class must be denied.

In **Beattie v. CenturyTel, Inc.**, 511 F.3d 554, 561 (6th Cir. 2007), the Sixth Circuit explained Rule 23(a)(3)'s typicality requirement:

Under Rule 23(a)(3), "the claims or defenses of the representative parties [must be] typical of the claims or defenses of the class." A claim is typical if "it arises from the same event or practice or course of conduct that gives rise to the claims of other class members, and if his or her claims are based on the same legal theory." In **Sprague v. General**

Motors Corp., 133 F.3d 388 (6th Cir.1998)], the Court explained that “[t]ypicality determines whether a sufficient relationship exists between the injury to the named plaintiff and the conduct affecting the class, so that the court may properly attribute a collective nature to the challenged conduct.” On the other hand, the **Sprague** Court explained, the typicality requirement is not satisfied when a plaintiff can prove his own claim but not “necessarily have proved anybody else's claim.” Lastly, for the district court to conclude that the typicality requirement is satisfied, “a representative's claim need not always involve the same facts or law, provided there is a common element of fact or law.”

Applying Rule 23(a)(3), it is clear that given the facts, Plaintiffs' claims are not typical of the class they purport to represent. Plaintiffs want to represent a class of female inmates that were denied regular access to feminine hygiene products. That may be a constitutional violation. See, e.g., **Carver v. Knox Cnty., Tenn.**, 753 F. Supp. 1370, 1389 (E.D. Tenn.) aff'd in part, rev'd in part, 887 F.2d 1287 (6th Cir. 1989). While the constitution “prohibits the denial of basic needs, including hygiene,” the Sixth Circuit has found that such claims must allege “extreme discomfort” or the complete denial of hygiene products. **Argue v. Hofmeyer**, 80 Fed. App'x. 427, 430 (6th Cir.2003). Here, none of the individual Plaintiffs claim that they were denied feminine hygiene products. In fact, at best, one Plaintiff claims she did not receive sanitary napkins for 2 days (Speers), while 5 of the remaining 7 claim they had to wait several hours after requesting them. Temporary deprivations such as this do not rise to the level of a constitutional violation. See **Gilland v. Owens**, 718 F.Supp. 665, 685 (W.D.Tenn.1989) (“Short term deprivations of toilet paper, towels, sheets, blankets, mattresses, toothpaste, toothbrushes and the like do not rise to the level of a constitutional violation.”); **Metcalfe v. Veita**, No. 97–1691, 1998 WL 476254, at *2 (6th Cir. Aug. 3, 1998) (finding that an eight-day denial of showers, trash removal, cleaning, and laundry did not result in seri-

ous pain or offend contemporary standards of decency under the Eighth Amendment). If any female inmates were ever actually denied feminine hygiene products, it is clear that Plaintiffs, all of whom admit to receiving them, would not present a claim “typical” of the class.

As for the alleged lack of exercise damages claim, Plaintiffs are not typical of the class they claim to represent. They assert that female inmates are denied all opportunity for exercise. They assert they were on lockdown for the majority of their incarceration. However, this is untrue. Most, if not all, of the Plaintiffs spent part of their time at the MCJ in 3e or 2e, the large day room cells. Plaintiffs in those cells are allowed out of their small double and single cells and into the large, open day room for the majority of each day. Further, inmates kept in the larger 12-person cells admit they were provided some opportunities to use the gym facilities. None of the Plaintiffs allege they were confined or on lockdown for extended periods of time without the ability to interact with other inmates, or denied the opportunity to use the entirety of either the dayroom or the larger 12-person cells. See *Rodgers v. Jabe*, 43 F.3d 1082, 1086-87 (6th Cir. 1995) (no minimum amount of outdoor exercise required to avoid Eighth Amendment violation); *Patterson v. Mintzes*, 717 F.2d 284 (6th Cir. 1983) (finding that court must take into consideration cell size and opportunity for interaction with other inmates when considering a claim for denial of out-of-cell opportunities). If there were female inmates kept in segregation, or locked down in their individual cells in 3e or 2e for extended periods of time without penalogical justification and with no out-of-cell opportunities, then a potential claim might exist. However, that is not alleged by any of the individual Plaintiffs, and therefore, they cannot claim their situations are typical of that alleged class.

Finally, with regard to Plaintiffs' damages claims for cross-gender viewing, the allegations of each of the Plaintiffs are not typical of the class they allege to represent. First, only one Plaintiff alleges her bra was taken while she was forced to use a one-piece jumpsuit (Bosch). As noted above, all female inmates have been issued two-piece jumpsuits for at least the past year. Further, the MCJ staff primarily uses female officers to patrol the female population cells. Additionally, the evidence will show when male guards are present in or patrol the female population areas, their presence is made known to the female population so as to eliminate the alleged opportunity for cross-gender privacy violations. The claims of these inmates, even if true, are atypical of the situation presented to most female inmates at MCJ.

Plaintiffs also cannot meet the adequacy requirement, which has two components: "(1) the representative must have common interests with unnamed members of the class, and (2) it must appear that the representatives will vigorously prosecute the interests of the class through qualified counsel." **Senter v. General Motors Corp.**, 532 F.2d 511, 525 (6th Cir.1976). Here, Defendants do not challenge the second component. However, it is clear that Plaintiffs do not have common interests with the unnamed members of the class for the same reasons they fail to raise the typicality requirement. No Plaintiff is a current inmate. Their individual allegations fail to allege actual constitutional violations. Therefore, they may deprive an inmate with a legitimate complaint from exercising her rights. Simply put, these Plaintiffs cannot be expected to adequately represent the alleged class.

2. All inmates damages class

As with the female-only damages class, Defendants do not contest the numerosity requirement for the general damages class. With regard to the commonality requirement, Plaintiffs' complaint references only situations faced by female inmates, yet they seek to represent all inmates. For example, Plaintiffs have presented no facts with regard to the male holding cells. Further, their sanitation claims are based only on their experiences within the female population cells (i.e., issues relating to having to shower in stalls where female menstruation discharge is located, and toilet issues in the female cells, the only cells where sanitary napkins are likely flushed and cause problems). Therefore, it is clear they do not share a commonality with the male population at the MCJ, which it is undisputed constitutes, on average, more than 80% of the total population.

Plaintiffs also fail the typicality requirement, which must be analyzed based on each of the alleged claims. Plaintiffs request this Court certify a class to recover damages for allegedly unconstitutional overcrowding and "other abysmal conditions." These conditions appear to be (1) overcrowding in general; (2) plumbing and overall sanitation; (3) overcrowding/extended stays in the holding tank; and (4) deliberate indifference to medical needs/ineffective internal complaint system. None of these allegations actually raises a constitutional claim, and even if it did, Plaintiffs cannot establish their situations are typical of most inmates.

It is clearly established that overcrowding, in and of itself, is not necessarily unconstitutional. *Johnson v. Hebron*, 88 F.3d 404, 407 (6th Cir. 1996) (citing *Rhodes v. Chapman*, 452 U.S. 337 (1981)). Therefore, Plaintiffs must present some constitutional

deprivation that results from overcrowding, and that their claims are typical of the entire class. This they cannot do.

Plaintiffs allege that due to overcrowding, some of them have been forced to sleep on the floor or on cots. However, it is clearly established that a prisoner has no right to sleep on an elevated bed. ***Mann v. Smith***, 796 F.2d 79, 85 (5th Cir. 1986); ***Hubbard v. Taylor***, 538 F.3d 229, 235 (3d Cir. 2008) (forcing pretrial detainees to sleep on a floor mattress for three to seven months due to overcrowding is not a constitutional violation); ***Grissom v. Davis***, 55 F. App'x 756, 758 (6th Cir. 2003) (seven-day deprivation of a mattress and bedding did not violate the Eighth Amendment); ***Jones v. Toombs***, 77 F.3d 482 (Table), 1996 WL 67750, at *1 (6th Cir. 1996) (two-week deprivation of a mattress is not a constitutional violation). Since this allegation does not even present a constitutional violation, it is clearly not typical of the alleged constitutional violations suffered by the purported class.

Plaintiffs assert they have been forced to stay in the holding cell for extended periods of time. First, their allegations as the length of their stays are exaggerated, as none of them ever stayed in the holding cell beyond 2 days, and most only for a few hours. This does not raise a cognizable constitutional claim. See ***Hutton v. Finney***, 437 U.S. 678, 686–87 (1978) (“A filthy, overcrowded cell and a diet of ‘grue’ might be tolerable for a few days and intolerably cruel for weeks or months.”); ***Holloway v. Gunnell***, 685 F.2d 150, 156 (5th Cir. 1982) (“allegations of two days of discomfort are not sufficient to state a claim of constitutional dimension”). That is, “temporary inconveniences and discomforts” do not rise to the level of a constitutional violation. ***Adams v. Pate***, 445 F.2d 105, 108–09 (7th Cir. 1971). Similarly, claims involving improperly-

cleaned showers, dirty mattresses, accumulated dust and dirt, and infestations of insects must rise above ordinary discomfort. See **Taylor v. Luttrell**, 2008 WL 4065927 at *9 (W.D. Tenn. 2008) (citing **Geder v. Godinez**, 875 F.Supp. 1334, 1341 (N.D. Ill. 1995)). Since none of the Plaintiffs can assert they suffered a constitutional violation based on their time in the holding cell, their claims cannot be typical of the purported class.

Plaintiffs also assert they have temporary plumbing problems, i.e. waiting up to two or three days for a shower to work. As already noted, temporary inconveniences do not rise to the level of a constitutional violation. Therefore, they cannot present a claim typical of the purported class.

Plaintiffs additionally assert that there is a constitutionally defective grievance and/or complaint system. It appears this claim is two-fold: (1) the system itself is constitutionally deficient, and (2) as a result of this defective system, the individual Plaintiffs suffered injuries. These will be addressed in turn.

The Western District of Kentucky recently summarized the law on this issue. In **Shelton v. Christian Cnty. Jail**, No. 5:14-CV-P146-GNS, 2015 WL 236853, at *1 (W.D. Ky. Jan. 16, 2015), the Court held:

An inmate grievance procedure within the prison system is not constitutionally required. See **United States ex rel. Wolfish v. Levi**, 439 F.Supp. 114, 163 (S.D.N.Y. 1977), aff'd sub nom, **Wolfish v. Levi**, 573 F.2d 118 (2nd Cir.1978), rev'd on other grounds, **Bell v. Wolfish**, 441 U.S. 520 (1979); **Spencer v. Moore**, 638 F.Supp. 315 (E.D. Mo. 1986); **O'Bryan v. Cnty. of Saginaw**, 437 F.Supp. 582, 601 (E.D. Mich. 1977). If the prison provides a grievance process, violations of its procedures do not rise to the level of a federal constitutional right. **Spencer**, 638 F.Supp. at 316. Because Plaintiff has no right to an effective grievance procedure, **Ishaaq v. Compton**, 900 F.Supp. 935, 940–41

(W.D. Tenn. 1995); **Flowers v. Tate**, Nos. 90–3742, 90–3796, 1991 WL 22009 (6th Cir. 1991), a failure to follow the grievance procedures does not give rise to a § 1983 claim. *Id.*; **Azeez v. DeRobertis**, 568 F.Supp. 8, 10 (N.D. Ill. 1982). Thus, Plaintiff's claim relating to the lack of adequate grievance procedures must be dismissed.

Similarly, Plaintiffs' allegations regarding the inadequate grievance/complaint system at the MCJ fail to state a claim or even present a claim typical of the purported class.¹⁵

To the extent that Plaintiffs' allegations regarding the grievance system assert a denial of medical care, such claims are not typical and rarely suffice to support class certification. For example, in **Rouse v. Caruso**, No. 2:06-CV-10961, 2013 WL 5775354, at *4 (E.D. Mich. Oct. 25, 2013), the Eastern District of Michigan recently rejected a request for class certification under (b)(3) based on medical care claims:

Based on the record, Plaintiffs' claims carry with them so many individual questions of law and fact and liability that the common questions do not predominate over the individual questions. See, e.g., **Turner v. Grant Cnty. Det. Ctr.**, CIV.A. 05–148–DLB, 2008 WL 821895, at *20 (E.D. Ky. Mar. 26, 2008) (“[T]here may be common issues of fact and law as to the existence and legality of [prison's] policies and practices. But these policies and practices are alleged so broadly and so generally that these fact and legal questions are too numerous and too common to be of practical benefit for discerning a common thread for each class.... [And] the individual aspects of both claims and defenses for each of the two proposed classes would be extensive. Thus, the predominance of common versus individual issues simply has not been established by Plaintiffs.”); see also **Schilling v. Kenton Cnty., Ky.**, CIV.A. 10–143–DLB, 2011 WL 293759, at *9–10 (E.D. Ky. Jan. 27, 2011) (holding that pris-

¹⁵ Defendants deny that the MCJ grievance and complaint system is ineffective. In fact, discovery will establish that it is precisely because of the complaint system that MCJ staff is able to report problems with plumbing, electricity, and other discomforts to the Muskegon Facilities department so they can be repaired as quickly as possible.

oners' claims of denial of medical care were too individualized to meet the "typicality" requirement of Civil Rule 23). Plaintiffs' have not met their burden under Civil Rule 23(b) (3). Accordingly, the Court will overrule the objections, adopt the Report, and deny the renewed motion for class certification.

The same is applicable here. Plaintiff Vos complains that she had tooth pain, which was ignored. This is an individual claim for denial of medical care not typical of any others. Three Plaintiffs (Brown, Bosch, and Speers) claim they were burned by hot water. Again, these are individual damages claims not typical of the purported class and too individualized to meet the typicality requirement. Therefore, Plaintiffs' request for a general damages class must be denied.¹⁶

IV. Conclusion

Plaintiffs lack standing to pursue injunctive relief. None of them are a member of the injunctive classes they seek to certify. Therefore, the Court must deny their motion with respect to those two classes. Further, Plaintiffs cannot establish typicality or adequacy with regard to the two purported damages classes. Most, if not all, of the alleged injuries are not sufficient constitutional claims. Therefore, the Court should deny Plaintiffs' motion in its entirety. In the alternative, Defendants respectfully request this Court allow discovery to determine if the standards for class certification have been met.

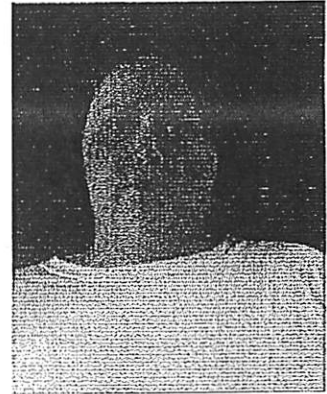

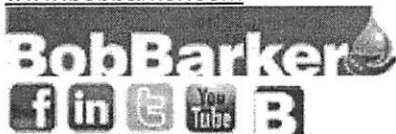

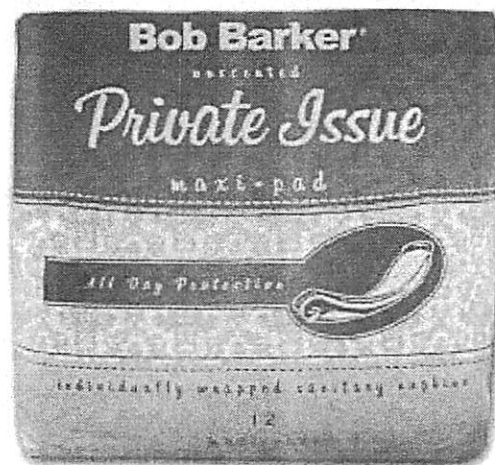
